



CONTRACT CIRCULAR FOR TRANSVERSAL CONTRACT RT275-2020 WHICH IS FOR SUPPLY AND DELIVERY OF SPEECH THERAPY, ASSISTIVE DEVICES AND ACCESSORIES TO THE STATE FOR THE PERIOD 1 JUNE 2020 TO 31 MAY 2023

1. PURPOSE

The purpose of this Contract Circular is to inform State Institutions about the Transversal Contract RT275-2020 for the Supply and Delivery of Speech Therapy, Assistive Devices and Accessories to the State for the period 1 June 2020 to 31 May 2023. The transversal contract is facilitated by the National Treasury, National Department of Health and Provincial Departments of Health for utilization by all State Institutions.

This Contract Circular is subject to the General Conditions of Contract (attached as **Annexure B**) issued in accordance with chapter 16A of the Treasury Regulations published in terms of the Public Finance Management Act, 1999 (Act 1 of 1999). The Special Conditions of Contract (attached as **Annexure A**) are supplementary to the General Conditions of Contract. However, where the Special Conditions of Contract conflict with the General Conditions of Contract, the former will prevail.

Category 10 : Therapy Resources

2.1.4 SERVICES

- Category 11 : Assistive Services

3. DURATION OF CONTRACT

3.1 The transversal contract period is for thirty-six (36) months commencing on 01 June 2020 to 31 May 2023.

3.2 The speech therapy, assistive devices and accessories can be procured at any stage within the transversal contract period when a State institution decided to participate.

4. IMPLEMENTATION OF THE TRANSVERSAL CONTRACT

4.1 The process to effect procurement thereof involves the following summarised undertakings (**detailed on procurement guideline attached as Annexure D**):

- Step 1 : Completion of the participation letter (Annexure C) and submit it to transversal.contracting2@treasury.gov.za;
- Step 2 : Acknowledgement via email (**no written post award consent letter will be issued to participant as the participation letter is customised to consent participation on completion and signing**) of participation letter by National Treasury and inform the appointed suppliers;

- Step 3 : Selection of any appointed supplier based on the State institution's speech therapy, assistive devices and accessories needs (more details on Annexure D procurement guideline);
- Step 4 : Contact supplier to verify the speech therapy, assistive devices and accessories availability;
- Step 5 : Issue a purchase order to the selected supplier based on the published prices on Annexure E;
- Step 6 : On delivery of items, verify if the delivered item(s) is according to the technical specification on Annexure E;
- Step 7 : Signing of the Participation Agreement (Annexure H) by Supplier(s) and Participants
- Step 8 : Submit quarterly report (Annexure I) to National Treasury on the performance of suppliers and the fulfilment of speech therapy, assistive devices and accessories needs through the transversal contract.
